For all options, a \$15 late fee will be charged for each payment that is received after the due date.

REFUND POLICY

\$500 of the entire program fee is non-refundable. \$450 of that deposit is transferable for up to one year to the next Anusara Yoga® Teacher Training for the same applicant. \$50 of the deposit is retained as a transfer fee. To transfer this amount, you must notify Todd in writing before the program start date.

Refunds to persons accepted into the program are as follows:

- If you withdraw up to 10 days before the program start date, your entire balance (less the \$500 deposit) will be refunded.
- If you withdraw from 10 days up to, but not including the program start date, 75% of your balance (less the \$500 deposit) will be refunded.
- On or after the program start date, there are NO REFUNDS and you are responsible for paying the entire balance for all three modules.
- If you withdraw any time during the program, on or after the program start date, and are on a payment plan, you remain obligated to make all remaining payments for the **entire program, which includes all three modules.**

LATE FEES AND EXTENSIONS ON HOMEWORK AND CERTIFICATION

Participating in Anusara Yoga® Teacher Training with Todd Norian is a big commitment of time and energy for the director, the assistants, and the students. We can serve you better if you submit your completed homework by the due dates and complete the training in the allotted time. However, we understand that due to unforeseen circumstances, this isn't always possible. The homework and certification extension financial policies are as follows:

- Late or Incomplete Homework: You will be charged \$25 for homework received after the due date or homework that is incomplete.
- Incomplete Certification Requirements: If you are unable to complete the certification requirements by the program end date, after you pass the second take home exam, or are asked to do additional work in order to receive certification, you may receive an extension. The fee for extension, which includes mentoring with a staff person, will be worked out individually with each student at a rate of \$75 per hour for staff time. (Total cost may vary depending on the amount of work and the duration of additional mentoring and supervision needed for certification.)
